This is an exciting opportunity for the successful candidate to drive forward a Department that has delivered outstanding results for a number of years. They will also make a positive contribution to the wider life of a busy day and boarding school.

About Us

Clifton College is a leading independent day and boarding school educating over 1,200 pupils aged 3 to 18. Founded in 1862, the College provides an all-round education, a rich heritage with modern state-of-the-art facilities. Located in the beautiful suburb of Clifton, we lead the way as one of the best independent schools in the country.

About You

We require an inspirational Head of Computer Science and Academic IT who is able to make a significant contribution to the development of the subject, showing creativity, passion and initiative. The candidate should ideally have experience of teaching both GCSE and A level Computer Science. Experience of teaching IT BTEC may also be of use.

The successful candidate will be a competent and enthusiastic programmer, with experience of a number of different languages, and evidence of a continuing interest in coding. Python and C# are used at GCSE and A level respectively, so proficiency in both these languages is essential. The successful candidate will also be a strong mathematician, holding a good grade in Mathematics A level or equivalent. They will have a good honours degree in the subject or a closely related qualification, and a teaching qualification would be an advantage.



The School sees this appointment as an exciting opportunity to review the teaching of all aspects of computing across the full 13–18 age range. The candidate must also be able to support a wide range of pupils and their needs, from those interested in vocational routes into the areas of IT and computing after school, to those interested in studying Computer Science at Oxford, Cambridge, and other top institutions.

Information Technology is currently taught to all pupils in Year 9, and also as a BTEC in Sixth Form. GCSE and A level Computer Science is an option for Year 10 and 12 pupils respectively.

In addition, the Department offers a number of opportunities to enthuse pupils about computing and explore its opportunities. These include Computing as an activity choice in Year 9, and a Coding Club open to all Years. For many years, pupils have successfully taken part in a number of national computing competitions, such as Bebras and the British Informatics Olympiad. We are looking for a teacher who will not only deliver excellence in the classroom but who will also inspire our pupils to develop their own passion for the digital world.

Specific Responsibilities

- Take responsibility for maintaining up-to-date schemes of work, department handbook, development planning documentation and other associated admin.
- Focus on planning and delivering outstanding lessons that inspire and enthuse pupils.
- Hold the highest expectations of all pupils irrespective of their ability or background.
- Work with the Learning Support Department, academic and pastoral teams to ensure that opportunities are provided for every pupil to make progress including the provision of extension activities for those who excel at the subject.
- Set challenging and rewarding prep tasks, and provide prompt feedback inline with school and department policy.



- Assess, record and report on academic and pastoral progress and attainment of pupils.
- Give a decisive lead to the delivery of Computer Science across Key Stages 4 and 5.
- Stay in touch with best practice within Computer Science teaching.
- Keep up to date with University requirements and courses, and advise pupils on their university applications as appropriate.

The ICT Department

The Department has two specially designed classrooms for delivering IT and Computer Science. The College has extensive and modern ICT facilities throughout the campus, including a super-fast Wi-Fi network.

The school has a very successful record in public examinations with both Computer Science and Information Technology. In 2023, at GCSE 53% achieved grades 7-9 (91% achieved grades 5-9), and at A level 67% achieved A*-A grades. 100% of BTEC IT candidates achieved *D or Distinction.

Extra-Curricular Computing

The school is keen for the department to offer opportunities for pupils across the school to develop their computing skills outside of the classroom. This may be developed through increased opportunities for pupils to take part in national competitions, and through appropriate trips and visits related to Computer Science.
